DATA CONTROLLER

In accordance with Law No 78-17 of 6 January 1978 on data processing, files and freedoms, as amended and Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, the CASH SYSTEMES INDUSTRIE Group, controller, informs you that the CSI and TOWA Internet and Extranet sites implement a system for processing personal data

concerning you when you access, connect and complete any contact forms that you may complete.

As a user of our CSI and TOWA Internet and Extranet sites, you are required to provide some of your personal data by logging in and completing the forms provided to you on these sites. The input of this personal data is necessary for the processing of your request by the CASH SYSTEMES INDUSTRIE Group.

We take all the necessary measures to:

- provide you with clear and transparent information on how your personal data will be collected and processed:
- implement all necessary technical and organisational measures to protect your personal data against disclosure, loss, alteration or access by an unauthorised third party;
- keep your personal data only for the time necessary and only for the purpose of the processing or service for which you are concerned;

COLLECTION AND PROCESSING OF YOUR PERSONAL DATA

WHEN DO WE COLLECT YOUR PERSONAL DATA?

Your personal data may be collected:

- when you fill out a form;
- when you visit our CSI and TOWA Internet and Extranet sites;
- when you subscribe to a newsletter.

We collect the information you provide us with, in particular:

- during your exchanges with our services
- during your visits to our CSI and TOWA websites
- when you connect to our CSI and TOWA Extranet sites

This personal data, collected on the CSI and TOWA Internet and Extranet sites, can only be sent from your voluntary registration.

It is only used within the limits specified at the time of collection to provide you with the service or related information.

WHO USES YOUR PERSONAL DATA?

The data processed are intended for authorised employees of our company, subject to confidentiality.

They are not transferred to any commercial company or other organization. They are not communicated to third parties except technical service providers involved in the site distribution process (companies providing system maintenance, hosting providers) and tax authorities upon request.

The processing operations with a service provider are the subject of a contract in order to ensure the protection of your personal data and the respect of your rights.

WHAT ARE THE PURPOSES OF PROCESSING YOUR DATA?

The processing of your personal data is based on the legitimate interest pursued by the CASH SYSTEMES INDUSTRIE Group when it pursues the following purposes: management of the commercial relationship, organisation, registration and invitation to Group events; execution of pre-contractual measures or the contract when it implements a processing operation for the purpose of: production, management, file monitoring and collection; compliance with legal and regulatory obligations when our Group implements a processing operation for the purpose of preventing money laundering, billing and accounting.

We do not carry out any profiling or any other automated processing of your personal data that is not legally authorized.

HOW LONG DO WE KEEP YOUR DATA?

The CASH SYSTEMES INDUSTRIE Group keeps your data only for the time necessary for the operations for which they were collected and in compliance with the regulations in force.

In this respect, your data are kept for the duration of the contractual relationship without prejudice to any retention obligations or limitation periods.

In terms of accounting, they are kept for 10 years from the end of the accounting year.

INDIVIDUAL RIGHTS

In accordance with Law No. 78-17 of 6 January 1978 and Regulation (EU) 2016/679 of the European Parliament and of the Council of the European Union of 27 April 2016 and within the limits set by the Law, you have the following rights:

• **Right to information:** You are informed of the personal data held and the purposes of the processing

- **Right of access:** You have the right to obtain confirmation that your personal data are being processed or not and to become aware of it.
- **Right of rectification:** You have the right to obtain, as soon as possible, that inaccurate personal data are rectified, and that incomplete personal data are completed;
- **Right to erase:** You have the right to obtain as soon as possible the deletion of your personal data if there is no legitimate reason to keep them;
- **Right to limitation of processing**: You have the right to obtain a limitation of processing when you are opposed to it, when you dispute the accuracy of personal data, when the processing is unlawful, or when you need it for the establishment, exercise or defence of your legal rights;
- **Right of objection:** You have the right to object at any time to the processing of personal data, except where it is necessary for the performance of a task in the public interest or for the legitimate interests of the controller. You may also object to the processing carried out for the purpose of prospecting;
- **Right not to be the subject of an automated decision:** You have the right not to be the subject of a decision based exclusively on automated processing, including profiling, which produces legal effects concerning or affecting it, except where such a decision is necessary for the conclusion or performance of a contract, is legally authorised, or is based on its consent.
- **Right to portability:** the data subject has the right to obtain the personal data he or she has provided, in a structured, commonly used and machine-readable format, and has the right to transmit these personal data without the initial controller being able to prevent it. The data subject may even request that such personal data be transmitted directly from one controller to another where technically possible. However, this right is subject to the condition that the processing is based on consent or a contract and that the processing is carried out by automated means.
- **Right to define general and specific directives** defining the way in which they intend to exercise, after their death, the rights mentioned above.

PROTECTION AND SECURITY OF YOUR PERSONAL DATA

Respecting your rights to the protection, security and confidentiality of your personal data is our priority.

Thus, all CASH SYSTEMES INDUSTRIE Group employees implement organisational and technical security measures adapted to the degree of sensitivity of personal data to protect them against any malicious intrusion, loss, alteration or disclosure to unauthorised third parties.

When developing, designing, selecting and using any service based on the processing of personal data, all entities of the CASH SYSTEMES INDUSTRIE Group take into account the right to protection of personal data from the outset.
